


Figure 1 – Gwynt Y Mor Project Area

Nature of Operations offshore

For the operations of N-sea the jack up barges will be used carry out maintenance work on one of the Gwynt Y Mor export cables – barges will be setup around locations 53° 18.1588 N / 003° 34.4364 W. We kindly ask that all vessels in the local vicinity observe a minimal distance of 500m stand-off at all times.

During the operation, the barges will be positioned on a fixed point and supporting vessels will sail to and from the barges. The barges and vessels will display prescribed lights and signals for operations and will be monitoring VHF Channels 16 and 12.
