- Introduction**

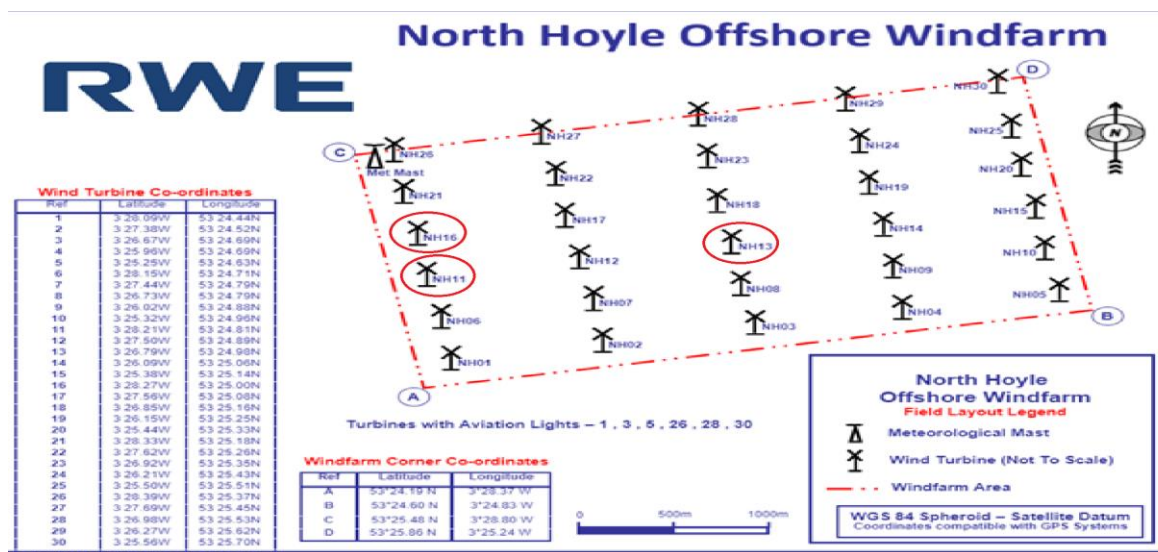
Please be advised that RWE Renewables UK will be carrying out maintenance operations including heavy lifting at North Hoyle Wind Farm situated off the North Wales Coast

Operations will take place at NH11, NH13, NH16 and will commence on or around 28th September 2024 and will take approximately 14 days to complete subject to weather

Vessel Details:

MPI Resolution is a 6 legged Jack-Up platform (Wind Farm Installation Vessel) measuring 130.00 metres in length by 38.00 metres in width. It has a 4.30 metre draft, coloured blue and white. When jacked up the MPI Resolution will be marked and displaying lights and day symbols in accordance with an Offshore Structure.



Requirements:

Mariners are requested to keep well clear and pass slowly, particularly when the craft is manoeuvring or during lifting operations.

Vessels are requested to:-

- (1) Give the MPI Resolution a wide berth of 500m during these operations
- (2) Gain permission from MPI Resolution prior to access / approach if required within the 500m zone
